I am writing to express my keen interest in the position of Councillor at the European Society of Cardiology (ESC). Over the last 10 years, I have served the ESC on a range of different boards and committees, and I am eager to continue to contribute to the society's mission and vision.

Professional Background:

I am Professor in Cardiovascular Nursing and Head of the Centre for Cardiovascular Health at Edinburgh Napier University. My academic journey includes a Bachelor of Arts (Honours) in Nursing (Queen Margaret University, Edinburgh) and a PhD in Secondary Prevention of Cardiovascular Disease (University of Sydney). Subsequently, I undertook a post-doctoral fellowship at the University of Sydney (2012-16), before returning to the UK to take up the position of Professor at Edinburgh Napier University in 2016. Over the years, I have diligently pursued research excellence, have published 150 peer-reviewed papers and have an H-Index of 38 (Scopus). My dedication to cardiovascular research is further underscored by the £5 million in research grants I have successfully obtained in the past five years.

Leadership and Advocacy:

My commitment to the field of cardiovascular health extends beyond research. I have the honour of serving as the Past President of the Association of Cardiovascular Nursing and Allied Health (ACNAP) of the ESC. During my tenure as President of ACNAP, I led initiatives that bolstered the society's influence and impact, particularly notable as I was president during the COVID-19 pandemic. Currently, I am privileged to lead the ESC Patient Forum, working closely with patients to weave a golden thread of patient-centred care throughout the ESC. In 2023, I was elected to Fellowship of the Royal Society of Edinburgh, Scotland's National Academy of Science and Letters. I am also the first nurse to serve as a National Health Service Research Scotland Cardiovascular Clinical Network Lead (2021-present).



Research Impact:

My research has pioneered the use of technologies, including smartphone apps, to prevent and manage cardiovascular diseases. I am currently leading a James Lind Alliance Priority Setting Partnership to identify key research priorities in digital health for heart health. I have also significantly contributed to the understanding and management of atrial fibrillation, a vital area in cardiovascular health. My work has not only been published in high-impact journals but has also influenced global guidelines and policies. For instance, my research was cited as Class 1 Level B evidence in the ESC guidelines on the management of atrial fibrillation, showcasing the practical implications of my contributions. Furthermore, my role as a mentor has allowed me to guide and support aspiring researchers. I have supervised the successful completion of 11 PhD students, and 3 Honours students, all of whom have achieved Upper Class Honours.

Community Engagement and Mentorship:

Engaging with the community is a cornerstone of my work. I have actively participated in numerous community events related to secondary prevention and atrial fibrillation screening, working consistently to raise awareness about cardiovascular health. I have championed the development of new clinics in Scotland, and link with policymakers to improve access to healthcare. I am passionate about patient and public involvement in research and have established a national cardiovascular patient and public involvement group.

Vision for the ESC:

If appointed as a Councillor, my vision would be to strengthen the ESC's position through my work with the ESC patient forum as a global leader in cardiovascular research and education. I am deeply committed to promoting multidisciplinary collaboration, fostering innovation, and advocating for patient-centred care. By leveraging my expertise in technology-driven healthcare solutions and my passion for patient advocacy, I aim to enhance the ESC's efforts in advancing cardiovascular health worldwide.

I am confident that my diverse experiences, research accomplishments, and leadership skills will enable me to continue to make significant contributions to the society's objectives.
